**4. First aid measures**

**FIRST AID MEASURES**

**Eye Contact** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**Skin contact** Wash skin with soap and water. In the case of skin irritation or allergic reactions see a physician.

**inhalation** If overcome by vapor, move person to fresh air. If person is not breathing, call 911 or an ambulance, then provide artificial respiration, preferably mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advise.

**INGESTION** Ingestion from an aerosol product is unlikely to occur. In case of accidental ingestion, do not induce vomiting unless directed by a physician. Seek medical attention immediately.

**Most important symptoms and effects, both acute and delayed**

**Symptoms** Acute: Prolonged inhalation of concentrated vapor or mist may cause headaches, dizziness and nausea. Prolonged and repeated contact with skin may cause irritation and reddening. Contact with eyes causes irritation. Exposure to d-limonene has been found to cause kidney damage in male rats. The mechanism by which this toxicity occurs is specific to the male rat and the kidney effects are not expected to occur in humans.

**5. Fire-fighting measures**

**Suitable extinguishing media**

Dry chemical, CO2 or water spray.
